The advantages of inculcating the traits of diligence and conscientiousness are, morality, augmenting skills and abilities; implementing tasks and activities in a well-organized manner; acquiring additional opportunities; achieving professional goals; acquiring appreciation and reverence; possessing the abilities to work under stress; depicting righteousness and effectiveness; promoting enrichment of personality traits; promoting enrichment of organizational culture and bringing about improvements in one's overall quality of lives. Finally, it can be stated, traits of

morality, diligence and conscientiousness are essential in promoting enrichment of overall living conditions.
